

Introduction

augustapentecostals.com takes your privacy very seriously. We recognize that this is an important issue to Internet users, so we design and operate our website with the protection of your privacy in mind.

Augustapentecostals.com does not sell, rent, loan, or give your email address or other personal information to any third party under any circumstance, and we will never do so. There are three exceptions to this rule:

1. When we are required to comply with a legal process;
2. When we feel the need to protect and defend our rights and property;
3. When we must protect against misuse or unauthorized use of augustapentecostals.com.

Data Collection & Usage

What we collect:

* Member & Visitor information, which is a compilation of personal facts and data such as your name, address, telephone number, email address, username, password, credit card information, etc. This information is kept private! Augustapentecostals.com will only use your personal information for purposes relating to your registration and for communicating necessary information to you. Only authorized employees may access this information.

* augustapentecostals.com collects personal information, such addresses and credit card numbers, for Visitors and Members who wish to make online donations or Tithe online.

* augustapentecostals.com collects email addresses on our newsletters signup page. This process is voluntary, and you can opt out of any of our newsletters at any time. You will not receive augustapentecostals.com newsletters unless you intentionally sign up for them.

* augustapentecostals.com collects limited, non-personally identifying information your browser makes available any time you visit a website. This log information includes your Internet Protocol (IP) Address, browser type, browser language, and the date and time of your query. We use this information to operate, develop, and improve our services.

* From time to time, augustapentecostals.com may ask you to participate in a survey. These surveys are conducted for the purposes of improving the types of services offered. The information collected from these surveys will never be shared with anyone outside of augustapentecostals.com.

Occasionally, augustapentecostals.com will send out email communications to resolve general issues that may arise, or to notify you of new services, changes in policies. Please note that augustapentecostals.com will never send attachments through email, nor will we ask you to email us personal information. We will never ask you to click a link from an email in order to update your account online. Such requests are fraudulent, and should be forwarded to abuse@augustapentecostals.com.com .

Cookies

When you visit augustapentecostals.com for the first time, a cookie is sent to your computer that uniquely identifies your browser. A "cookie" is a small file containing a string of characters that is sent to your computer when you visit a website. We use cookies to improve our services and to better understand how people interact with us.

For example, when you log in to augustapentecostals.com, you can check the "Remember Me" option. This stores your username and password in a cookie so you don't have to type it in every time you want to log on to augustapentecostals.com. Most browsers are initially set up to accept cookies.

You can, if you wish, set your browser to refuse all cookies or indicate when a cookie is being sent. However, some augustapentecostals.com features may not function properly without cookies.

Protection of Children's Personal Information

augustapentecostals.com is a general audience site and does not knowingly collect any personal information from children. While our website may be viewed by children, we do not wish to receive data from them. augustapentecostals.com encourages parents and guardians to spend time online with their children and monitor their usage. No information should be submitted to augustapentecostals.com by visitors under 18 years of age without the consent of a parent or guardian.
